

**Notice of Hearing and Site Visit  
Reclassification of Road**

Notice is hereby given pursuant to Title 19 Vermont Statutes Annotated, Chapter 7, as amended, that the Halifax Selectboard has received a petition from the requisite number of the Town's voters to reclassify a portion of Sumner Farm Road from a Class 4 Highway to a Class 3 Highway.

- I. The proposed reclassification from a Class 4 Town Highway to a Class 3 Town Highway is described as follows:

Sumner Farm Road from the presently existing intersection with Branch Road over and across a presently existing bridge for an additional distance of one hundred+/- (100'+/-) feet.

The aforementioned road and the section proposed to be reclassified by petition of Town voters will be outlined and highlighted on a map to be posted at the Town Clerk's Office, 246 Branch Road, West Halifax, Vermont. Further reference may be had to said map. All abutters and interested persons will be notified in accordance with Title 19 V.S.A. Chapter 7.


THEREFORE, the Selectboard will meet at the Town Office Meeting Room, 246 Branch Road, West Halifax, on May 27, 2015 at 5:00 P.M. to conduct a site inspection of the above road, then reconvene at the Halifax Multipurpose Room on May 27, 2015, at 7:00 P.M. to conduct a hearing on the question of reclassifying the above described road. The Selectboard will then determine whether the public good, necessity and convenience of the inhabitants of Halifax require these changes.




The purpose of the hearing shall be to hear all persons interested in said public highway laying out and alteration.

**Notice of Hearing and Site Visit  
Reclassification of Road**

Notice is hereby given pursuant to Title 19 Vermont Statutes Annotated, Chapter 7, as amended, that the Halifax Selectboard, on its own Motion which Motion passed at the April 7, 2015 Selectboard meeting will consider reclassification or discontinuance of the following four roads: (1) Whitneyville Road; (2) Woodard Hill Road; (3) Weir Road; and (4) Sumner Farm Road. The Motion stated "that the Selectboard consider reclassification or discontinuance of the following roads in conjunction with the Sumner Farm Road petition: Whitneyville Road, Woodard Hill Road, and Weir Road, and to keep the option of discontinuance for Sumner Farm Road."

- I. The following roads will be considered for reclassification, and/or for discontinuance by the Town:
  1. Whitneyville Road, by AOT, is a Class 3 road with a four-tenths mile section designated Legal Class 3, 'not up to standard' and will be considered for reclassification as a Class 4 road or Town Trail, and for discontinuance;
  2. Woodard Hill Road is a Class 3 road with a half-mile section designated Legal Class 3/Functional Class 4 and will be considered for reclassification to a Class 3 or Class 4 road, or Town Trail, and for discontinuance;
  3. Weir Road is a Class 4 road, as determined by the State of Vermont after Tropical Storm Irene, and is 0.6 miles long and will be considered for reclassification to a Class 3 road or a Town Trail, and for discontinuance;
  4. Sumner Farm Road is a Class 4 road, and will be considered for reclassification to a Class 3 road or for discontinuance from the Sumner Farm Road intersection with Branch Road over and across a presently existing bridge to Sumner Farm Road's terminous.

The aforementioned roads and the sections proposed to be reclassified or discontinued will be outlined and highlighted on a map to be posted at the Halifax Town Clerk's Office, 246 Branch Road, West Halifax, Vermont. Further reference may be had to said map. All abutters and interested persons will be notified in accordance with Title 19 V.S.A. Chapter 7.

THEREFORE, the Selectboard will meet at the Town Office Meeting Room, 246 Branch Road, West Halifax, on May 27, 2015 at 5:00 P.M. to conduct a site inspection of the above roads in an order to be determined at that time, then reconvene at the Halifax Multipurpose Room on May 27, 2015, at 7:00 P.M. to conduct a hearing on the question of reclassifying the above described road. The Selectboard will then determine whether the public good, necessity and convenience of the inhabitants of Halifax require these changes.

In the event of inclement weather, the Selectboard shall post "Notice of Inclement Weather" at the Town Office. The alternate date set is Thursday, May 28, 2015, following the format prescribed above.

The purpose of the hearing shall be to hear all persons interested in said public highway laying out and alteration.
