## Warning Annual Town Meeting March 5, 2013

The inhabitants of the Town of Halifax, Vermont who are legal voters in the Town are hereby notified and warned to meet at the Halifax Elementary School in West Halifax, Vermont on Tuesday, March 5, 2013 at ten (10:00 A.M.) o'clock in the forenoon to act on the following business:

ARTICLE 1: To elect by Australian Ballot all Town Officers required by law to be elected at the Annual Town Meeting and to fill all vacancies. The polls will be open from 10:00 A.M. to 7:00 P.M. to vote for the following Town Officers:

ARTICLE 2: To hear the reports of the Town Officers and to act thereon and to see if the Town will accept the Town Report as printed for the fiscal year ending June 30, 2012.

ARTICLE 3: To see if the Town will vote to collect taxes for the Town and Town School District as follows: Taxes will be due on or before September 30, 2013 payable to the Town Treasurer. Taxes will become delinquent after September 30, 2013 and payable with penalties and interest to the Collector of Delinquent Taxes.

ARTICLE 4: To see if the Town of Halifax will vote to apply any budget surplus from the current fiscal year FY13 to reduce taxes in the next fiscal year FY14.

ARTICLE 5: To see if the Town will vote to approve Selectboard and Highway expenditures of \$1,442,743, of which \$879,743 shall be raised by taxes and \$563,000 by non-tax revenues to care for the expenses and liabilities of the Town for the 2014 fiscal year.

ARTICLE 6: To see if the Town will vote to set the Treasurer's budget for salary and collection of current taxes at \$13,000 plus \$4,000 for expenses for the 2014 fiscal year.

ARTICLE 7: To see if the Town will vote to raise and appropriate the sum of \$10,000 for a Certified first and/or second Constable, or first and/or second Constable attending the academy, or otherwise \$2,000 for a non-certified first and/or second Constable's budget for the 2014 fiscal year.

- ARTICLE 8: To see if the Town will vote to raise and appropriate the sum of \$1,900 to support the home health care and hospice of patients in their homes by staff and volunteers of the Visiting Nurse Association and Hospice of Vermont and New Hampshire, Inc.
- ARTICLE 9: To see if the Town will vote to raise and appropriate \$3,000 for the Whitingham Free Public Library in recognition of services provided to the residents of Halifax.
- ARTICLE 10: To see if the Town will vote to raise and appropriate \$20,500 for EMS and ambulance service, utilizing area agencies for the 2014 fiscal year.
- ARTICLE 11: To see if the Town will raise and appropriate \$2,500 to Wings Community Programs to assist with the costs of providing after-school and summer programming for the children of the Town of Halifax.
- ARTICLE 12: To see if the Town will raise and appropriate \$1,000 in support of the Halifax Community Club, Inc.
- ARTICLE 13: To see if the Town will raise and appropriate \$500 in support of the Deerfield Valley Community Partnership to assist with the cost of providing programming and activities to prevent youth drug and alcohol use.
- ARTICLE 14: To see if the Town will adopt the following as an official seal to be used on town stationary, town vehicles, a town flag or other media wherever an official town seal would be appropriate, without changing the embossing seal used by the Town Clerk.

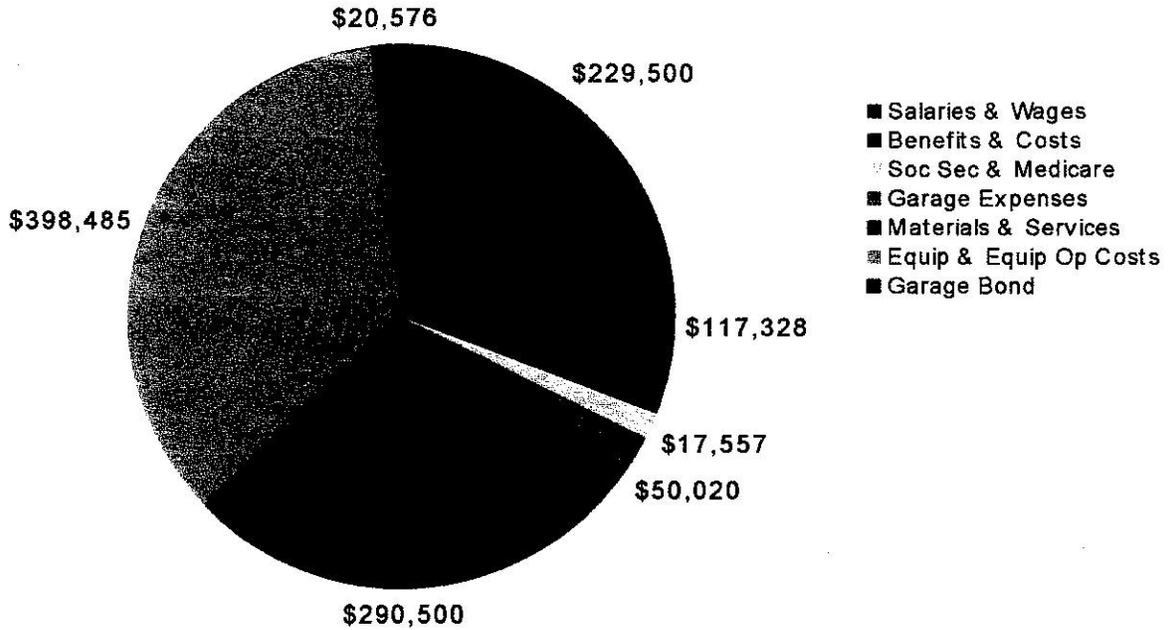

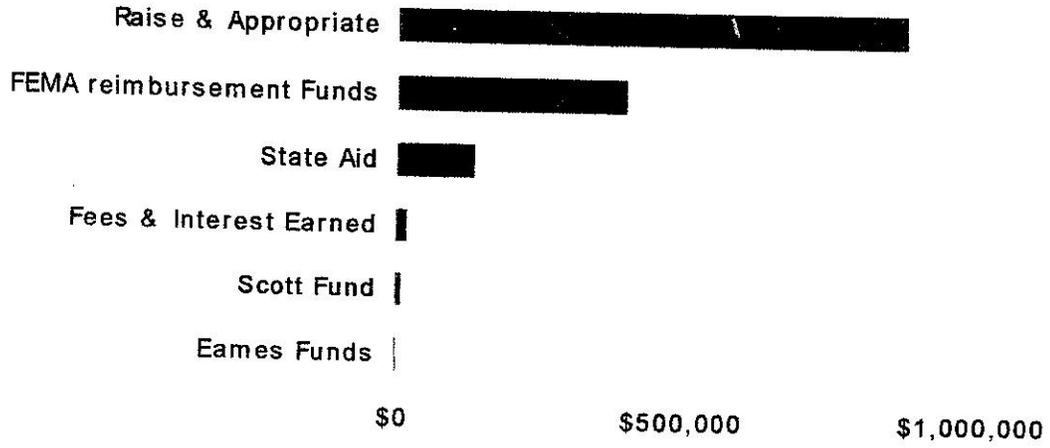
Selectboard Budget Expenses in %  
 FY14 Total = \$1,442,743



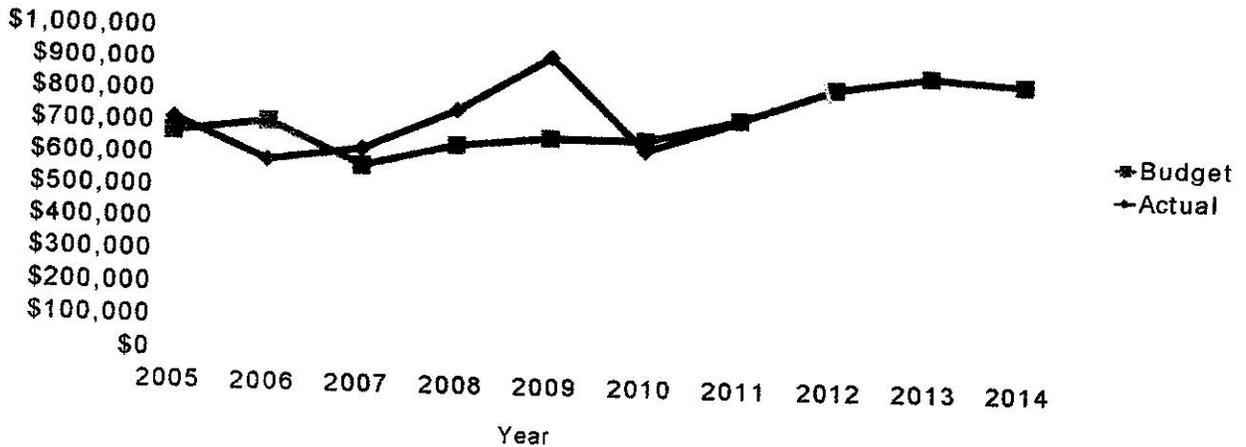
Halifax Highway Expenses - FY14

## TOWN OF HALIFAX – AUDITORS ANNUAL REPORT

We reviewed the records of the Town Treasurer, Road Commissioner, Delinquent Tax Collector and other municipal officers provided for period ending June 30, 2012. We reviewed bank reconciliations, analyzed activity for the trust funds and delinquent tax collections.

We conducted the annual Town audit for Fiscal Year Ending June 30, 2011 in accordance with the statutory requirements identified at 24 V.S.A § § 1681, 1682(a). This statutory requires that the elected auditors review the accounts of local officials and report the findings directly to the taxpayers for review through the annual Town Report. Auditors may make notes to bring irregularities to light, but may not change the actual reports provided by the municipal officials.

Through our review and testing of the financial documents we received we were able to obtain reasonable assurance that the financial records presented within this annual report are free from material misstatement. Do note that records are kept on a cash basis rather than the accrual basis, therefore income is recorded when the cash or check is received and the expenses are not counted until they are actually paid.

We have done our best to review the records provided by municipal officials. We would like to remind you that all financial records are available upon request from Town Officials if additional questions remain.

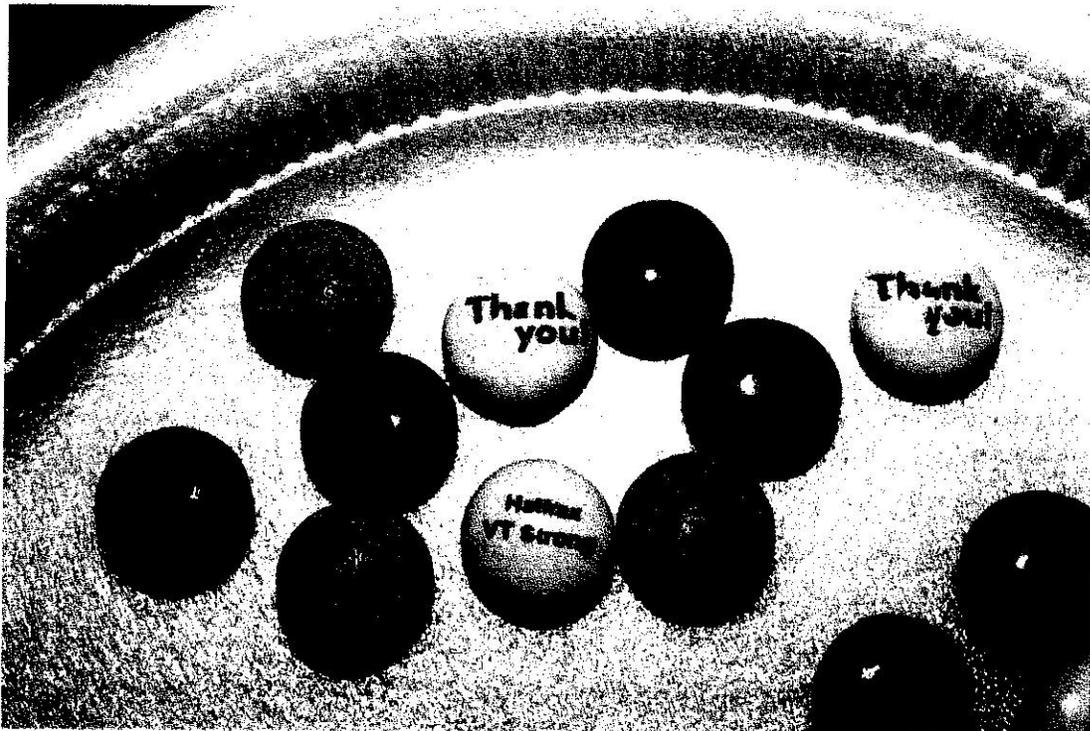

Selectboard Report for FY 2012

Tropical Storm Irene's impact was a major theme for the Selectboard in FY 2012, which ran from July 1, 2011 to June 30, 2012.

**Finances:** Because of the storm's late August 2011 arrival, the timing of our tax payment receipts in September helped us through the initial weeks of repairs. We were very grateful to receive a short-term loan from the Halifax School board, which we paid off as planned. Finally, we opened a short-term line of credit to the tune of \$2 million dollars. Much of this loan has been paid off as FEMA (Federal Emergency Management Agency) funding has been received, but we will need additional loans to finish the remaining bridge work. The FY 2012 budget deficit is largely due to Irene; work and project financial closeouts will continue in FY 2013 and possibly beyond. State funding, as discussed in Town Meeting 2012, will help keep Halifax's final town contributions low.

**Infrastructure:** We were grateful for a long fall and low-snow winter, which allowed the Town Highway Department and contractors to get our final roads (Green River and Stowe Mountain) open in December 2011. By the end of the fiscal year, all but 3 of our damaged bridges had been repaired, with a temporary bridge in place for Bridge #34 (Deer Park at Green River Road); a temporary repair and weight limit on Hale Road; and work underway on Reed Hill bridge #33. (At the time of writing this report in November 2012, Reed Hill bridge has been opened, and work on the Deer Park permanent bridge is underway.) Meanwhile, the Highway Department replenished our gravel supply and continued regular maintenance and some planned upgrades.

The regularly scheduled repaving on Green River Road between Hatch School intersection and Ballou Mountain Road will be completed next summer, as planned. Grinding the old pavement and letting the road compact was recommended by VT Agency of Transportation, and also let us spread those costs over 2 years. We have also contracted out the engineering work for a replacement bridge on Old County Road North (not Irene damage, but regular bridge work).

**People:** The Selectboard said goodbye to our long-time secretary Phyllis Evanuk, and welcomed Jessica Bruno as our new secretary. We are also grateful to the many neighbors who serve in appointed and elected positions.

The Selectboard encourages citizen involvement. Please express your interest in Appointed positions, listed in this Town Report. Some of these positions are compensated; many others are not. Appointments are made by the new board in the first and second meetings after Town Meeting. Also join us at our meetings, usually the 1<sup>st</sup> and 3<sup>rd</sup> Tuesdays of each month at 6:30 pm in the Town Offices, presuming the new board keeps this schedule. Special meetings (time permitting) are announced on the town website ([www.halifaxvermont.com](http://www.halifaxvermont.com)), as well as warned as required by law with physical postings.

## Road Commissioners Report

## Emergency Medical Services

Emergency Medical Services (EMS) is the busiest of the emergency services in Halifax. The number of emergency calls for medical assistance increases year after year. The residence of Halifax are served by a number of organizations that provide EMS. This report endeavors to provide an overview on the all of the related activities and organizations.

### HALIFAX EMS

March of 2013 marks our fifth anniversary. I am very proud of our accomplishments and our volunteers. The community's investment in Halifax EMS pays dividends in many ways. For example, those who have joined found tremendous personal benefits. For one member, it opened up a new paid career. For another member, the pursuit of a college degree.

At present we have one paramedic, one finishing her training and one starting the 2,000 hour training program. A paramedic is the top certification in EMS. We are hoping that in the next years, we can upgrade the organizations license to offer paramedic services to our patients.

### WHITINGHAM AMBULANCE SERVICE, INC.

Whitingham Ambulance Service, Inc (WASI) has gone through a few struggles during the recent years. WASI has traditionally served three towns, but during the summer of 2011, the Town of Readsboro withdrew from the consortium. This meant that almost half of our calls disappeared. With that, the revenue from billing insurance companies also disappeared. We lost one third of our operational grants as Town of Readsboro no longer contributes. Reimbursement from insurance companies has also been decreasing as Medicare and Medicaid under-go financial scrutiny.

The three factors above threaten the long-term financial of WASI. In addition, each ambulance call requires 3-4 hours of dedicated work from at least two volunteers. When calls come it at night, volunteers struggle to cover the calls and get to work in the morning. During the day, calls cause volunteers to miss hours of work. The WASI board of trustees is striving to find a method of keeping a local ambulance service viable and available to our two towns.

### RESCUE INC

Rescue Inc provides the ambulance service for Thomas Hill, Lucier Rd, Hale Rd and Hosea Fisher Ln. They also intercept Whitingham Ambulance when we require paramedic services. Rescue Inc covers 15 towns in VT and NH from two bases: one in Brattleboro near the hospital and one in Townshend at Grace Cottage Hospital. A number of changes have been noted with Rescue Inc as they struggle to meet changing financial situation. Three members of Halifax EMS left Rescue Inc during this recent year.

## Hurricane Irene

Hurricane Irene was a large and very destructive tropical cyclone which affected much of the Caribbean and East Coast of the US during the 2011 Atlantic hurricane season. Prior to Irene, the only other tropical cyclone to hit Vermont came in 1938. Evidence indicates that the water levels from Irene exceeded the 1938 storm. According to the National Weather Service, Irene was a Category 1 Hurricane strength when it crossed the Massachusetts/Vermont border. Irene hit Halifax on Sunday 28 August 2011.

Every water course in Halifax flooded causing extreme damage. Four town-owned bridges were destroyed by debris-filled and fast-moving water. Miles of town-owned road were destroyed. While a few private homes reported damage from flood waters, no homes were destroyed or condemned. Residents did lose property as the rivers claimed new pathways and extended their banks.

Halifax was spared damage from high winds. There were no spontaneous fires. There were no deaths within the town attributed to the storm.

The Halifax Emergency Operations Center (EOC) opened during the storm under the direction of Emergency Management Director Lewis Sumner. The EOC, based at the Halifax Fire Company's station at 118 Branch Rd, managed the initial response and recovery from the storm. The EOC closed on 17 September 2011. The EOC operated under the structure of the Incident Command System.

The purpose of the report is document the long-term recovery work and the long-term costs.

## Recovery Funding

FEMA and the State of Vermont are aiding the town with financial recovery, primarily under authority of the Robert T Stafford Act. Specifics on the Stafford Act can easily be researched in public documents. Initially, the support was split three ways: FEMA 75% - State 12.5% - Town 12.5%. In time, the governor negotiated 90% reimbursement from FEMA. By February 2012, the state's executive recognized that tiny towns would be crippled for decades with bonds to fund their 5% burden. The state developed a formula whereby towns were capped at 3-cents on their Grand List value. While the town remains to have a contributory portion, our risks were capped by this rule. For practical purposes, Halifax will receive 100% reimbursement funding split: FEMA 90% - State 10%. Funding data and notes about this recovery are often noted with a "4022". The official disaster designation for Irene in Vermont was described in a document entitled: FEMA-4022-DR-VT.

Until "Project Close Out", a formal process that will occur after all construction, reimbursements are capped at 81% of the FEMA estimated value of the project. In short, the State of VT is reimbursing towns at 90% of the funds provided by FEMA (which intern is also 90%). After close out, the State of VT and FEMA will bring the balance of funding to the anticipated "near 100%" level.

## Preliminary Damage Assessment

In the early hours, the damage assessment performed by the EOC staff came to between \$3 million and \$6 million.

## Project Worksheets

FEMA and the State of Vermont use the phrase Project Worksheets to capture costs and describe the specifics of damage, reconstruction and mitigating steps. During 4022, a small project was defined at just less than \$67,000. A large therefore greater than \$67,000. Small Projects funded immediately based on estimated costs. Large Projects

are funded based on the actual costs of recovery. There were approximately 40 projects defined for Halifax.

The project worksheets provide an estimate of damage at \$4.5 million.

## Town Labor, Labor, & Materials

FEMA reimburses for labor engaged in reconstruction. During this disaster FEMA paid regular wages and overtime for all town employees while they were engaged directly in reconstruction. The detailed records the town crew kept allowed the town to bill the disaster approximately \$92,000 for labor.

FEMA "rents" equipment engaged in reconstruction. FEMA pays according to a public schedule adjusted annually. The detailed records the town crew kept allowed the town to bill the disaster approximately \$218,000 for equipment rental. There are few costs associated with this money: short term lease of a backhoe, routine maintenance, and fuel.

FEMA pays for material used to repair damage. Because the town yard doubles as a gravel pit, the town was able to "sell" gravel at fair-market-value to FEMA. The detailed records the town crew kept allowed the town to bill \$86,000 for material, primarily gravel. Most of this gravel was harvested in our town pit, therefore had little-to-no underlying costs. Some gravel was stockpiled during an investment we made in 2010.

The Town of Halifax will receive approximately \$400,000 (sum of above) in reimbursement for the use of town assets. As of December 2012, we have received approximately \$320,000 of these funds. The funds are integral to the project-based reimbursements.

Additionally, FEMA will fund the administration of their program by allowing towns to collect up to 3% of the total value of projects. The time I have invested into this project will be reimbursed by FEMA and the State of Vermont. My wages, materials, miles and such will be covered under this allocation. These funds also pay the wages of Joe Tamburrino, our purchasing agent and a portion of Patty Dow, treasurer. Note (for those quick with calculators), we will only collect for actual costs, not just the flat 3% (oh, I do wish).

## Lessons to Carry Forward

Photographs and sepia colored memories remain from the 1938 Hurricane - a storm I have heard about all of my life. Yet, Halifax has been hit by a federally declared natural disaster each of the last three odd-numbered years. Most resulting in a few hundred thousand dollars of damage.

The formality of using detailed documentation, working as an integrated team, following complicated/complex rules created an environment for the Town of Halifax whereby we will recover all possible funds from federal and state resources. We have had to borrow money on short-term basis from banks.

While we can not get reimbursed for the interest we pay, please recognized that under the normal application of the Stafford Act, Halifax would have been responsible for \$562,000 in long term debt. This value is 12.5% of the total cost of reconstruction (\$4.5M). We would have been carrying this debt as a bond for decades. Even under the generous ruling that towns must pay only 5% of the reconstruction costs, our portion would have been \$225,000, a value roughly a quarter of the town's operating budget. Without federal support, we would have faced \$4.5 million in recovery costs. Our state government became an ally and partner in this recovery.

We did well. Volunteers blazed trail to check on neighbors. Food and water was carried to those in need. We rebuilt our roads and worked around broken bridges. Fiscal recovery may take as much as four years, when it is done, our bills will be paid. The reimbursements for labor, equipment, and gravel will cover interest rates, help us restock our gravel piles and keep our equipment current.

Stay prepared. Keep fresh water, dried/canned food on hand. Keep 3 days to a week of daily medications in stock. Care for yourselves and your neighbors.

## Halifax Broadband Committee

We are happy to report that the Halifax School Board signed up for the FiberConnect project to bring a fiber optic line to the school, which will provide Internet service of up to 50 Mbps. As of October, 2012, Sovernet is currently bringing the fiber optic lines to southern Vermont, and the school is expected to have service around December, 2012. Other providers may be able to tap into the fiber line in the future to bring broadband to homes and businesses in Halifax.

Wireless Internet service is expected to come to Halifax through VTel by December, 2013. There are up to 29 addresses in town that will not receive this service from VTel, but the Broadband Committee is working on a solution for these un-served addresses. FairPoint also received a grant through the Connect America Fund to expand their broadband service. There are many residences in Halifax that will have an opportunity to receive broadband service through this grant as well.

There is a potential VTA disaster grant that could bring cell service along Route 112. There is no guarantee that the town will get the grant, but if it does, the grant will also support a Wi-Fi hotspot.

The Broadband Committee also merged with the Website Committee earlier this year. We have made many improvements to the format, content, and usability of the town website.

HOUSING REHABILITATION COMMITTEE

The Housing Rehabilitation Committee, a consortium of our three towns, continues to distribute funds in low-interest loans to income-eligible residents for a variety of rehabilitation projects, ranging from septic and well installations, heating, and roofing, to plumbing and electrical repairs and upgrade. The Committee approved several new loans in the past year, and several older loans have been paid off; we have served sixteen clients this year, with current loans amounting to \$170,680.41 in principle. Funds available for new loans to income-eligible applicants are \$137,651.28.

Our Committee is one of the few in Vermont that remain active and self-sufficient in the administration of funds recycling from repaid loans. The Committee has funds to lend and invites the residents of our three towns who may have a necessary rehabilitation project to apply to see if they meet eligibility guidelines. *As part of the Medicare Part D prescription drug program our trained staff offered assistance to 5 residents.*

**Senior Nutrition-** *Home delivered meals are arranged through an arrangement with the Jacksonville Meal site. Congregate meals are offered in Halifax and Jacksonville. We pass through to them the federal and state funds that we receive. A Registered Dietician is available to offer nutritional counseling when appropriate.*

**Transportation-** *We support various providers of transportation for both medical appointments and non-medical needs.*

**Case Management & Advocacy-** *Case managers offer support in elder's homes by assisting with applications for benefits, insurance problems, fuel assistance, housing problems, etc. Our agency served 9 Halifax residents during this past year.*

**Caregiver Respite-** *Through grants we provide respite for family members who are caring for an aging parent.*

## 2012 – Vermont Department of Health Town Reports

The Vermont Department of Health is working for your health every day. With our headquarters and laboratory in Burlington and 12 district offices around the state, we deliver a wide range of public health services and support to your community. For example, in 2012 the Health Department:

- Supported community coalitions to help make the healthy choice the easiest choice. Deerfield Valley Community Partnership was awarded \$96,946. to support Healthy Retailers, prevent alcohol and drug abuse, reduce exposure to second hand smoke, and help smokers to quit.
- Served about half of all Vermont families with pregnant women and children to age 5 with WIC (Women, Infants and Children Supplemental Nutrition Program). WIC provides individualized nutrition education and breastfeeding support, healthy foods, and a debit card to buy fruit and vegetables. In Halifax 31 women, infants and children were enrolled in WIC. The average value of foods provided is \$50 per person per month.
- Promoted immunizations and worked to control the spread of infectious diseases like influenza, measles and pertussis (whooping cough). This year saw another rise in the number of cases of pertussis, from 95 statewide in 2011 to 471 by December 2012
- Launched a new online resource that brings environmental and public health data together in one place, at [www.healthvermont.gov/tracking](http://www.healthvermont.gov/tracking) The Tracking portal has county-level searchable data and information about air quality, asthma hospitalizations, birth defects, blue-green algae, cancer rates, carbon monoxide poisoning, drinking water, heart attacks, lead poisoning and reproductive health – with links to national data.

Vermont League of Cities and Towns 2012 Overview  
*Serving and Strengthening Vermont Local Government*

The Vermont League of Cities and Towns (VLCT) is a nonprofit, nonpartisan organization that is owned by its member municipalities and directed by a 13-member Board of Directors comprised of municipal officials from across the state elected by the membership.

VLCT's mission is to serve and strengthen Vermont local government. All 246 Vermont cities and towns are members of VLCT, along with 141 other municipal entities, including villages, solid waste districts, regional planning commissions and fire districts.

Vermonters use local government services, including highways, police, fire, recreation, libraries, sewer, and water, on a daily basis. In large part, volunteer elected and appointed municipal officials lead these local governments.

VLCT provides the following services to its member cities and towns, so that they may provide their citizens with quality services at affordable costs:

- Legal, consulting and education services. In the past year, VLCT responded to more than 3,000 inquiries for assistance from municipal officials. Our Municipal Assistance Center (MAC) conducted 15 workshops that attracted more than 1,300 people. Additionally, we conducted 12 "on-site" workshops held at municipal offices on a wide range of topics. Handbooks produced by MAC may be purchased or accessed free of charge on our website at our Resource Library. The Library also contains nearly 1,000 other electronic documents, including technical papers, model polices and newsletter articles that are currently accessible to the general public. MAC has also retained the services of professionals in municipal finance, administration, and policing to provide consulting advice to towns.
- Advocacy representation before the state and national governments to ensure that municipalities have the resources and authority they need to serve their citizens. VLCT is a leader in the education finance debate, enhancing local voter authority in governance decisions, land use discussions, and securing revenues for town highway and bridge maintenance programs. Municipalities will face significant challenges in the 2013 legislature, as limited financial resources at the national and state level force more demand for services to the local level.
- Purchasing opportunities to provide needed services at the lowest cost. Examples include municipal employee health insurance and liability coverage for town operations. The VLCT Health Trust represents the most affordable option available to provide health insurance to municipal employees. The substantial municipal damages resulting from Irene last year made the value of **VLCT Property and Casualty Intermunicipal Fund (PACIF)** to all our members painfully clear with members benefitting from the broad coverage, excellent re-insurance and prompt service and claims payments. These two trusts, with the addition of the VLCT Unemployment Trust, were responsible in 2010 for \$43 million in municipal tax dollars spent for insurance and risk management services.

We would like to express our gratitude to the Town of Halifax for its longstanding support of the work of the Visiting Nurse & Hospice of Vermont and New Hampshire. Understanding the significant pressures on the town budget, we respectfully request a level funding allocation of \$1,900 for the upcoming year.

The Visiting Nurse & Hospice is hard at work in your community. As a compassionate, nonprofit healthcare organization, the Visiting Nurse & Hospice of VT and NH is dedicated to providing the highest quality healthcare and hospice services to individuals and their families, regardless of their ability to pay.

A note I recently received demonstrates the effect our agency has on people needing our services: "The nurse who visited the day I was there was skillful, patient and generous with her time. She was a great comfort... The weather conditions that day were difficult. Ice and snow covered the roads. The nurse trudged up a slippery hill, arrived at the door with a smile on her face to help... The nurse was a pure gift to all of us during that visit."

We provide short-term care for those who need skilled services after hospital discharge and long-term care for people who have chronic or complex medical problems. As the largest provider of hospice services in the area, we provide round-the-clock comprehensive and team-based hospice care, including pediatric hospice and community bereavement services. We also provide many no- or low-cost services to the community, including wellness clinics, foot care clinics and flu clinics, as well as education, and referral and coordination with other allied community services.

Like the local rescue squad or fire department, the Visiting Nurse & Hospice provides Halifax residents a measure of safety and security. Additionally, our services help to keep residents out of emergency rooms, hospitals and other institutions, likely contributing a significant savings to the town's emergency medical service expenses.

Last year, the Visiting Nurse & Hospice made approximately 132,000 home visits to 5,000 patients. Unfortunately, many of these services are not fully covered by insurance, which resulted in over \$4 million in unreimbursed charges for services. **In Halifax, we made 119 homecare visits to 6 residents. The Visiting Nurse & Hospice absorbed approximately \$4,962 in unreimbursed charges to Halifax residents.**

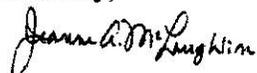

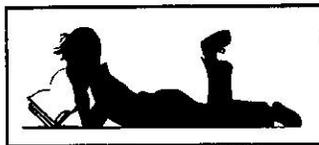
Additionally, Halifax residents made visits to Visiting Nurse & Hospice community clinics for foot care, blood pressure screenings, cholesterol testing and flu shots.

## The Windham Regional Commission

The mission of the Windham Regional Commission (WRC) is to assist towns in Southeastern Vermont to provide effective local government and work cooperatively with them to address regional issues. In the absence of county government, we provide an essential link between towns, the state, and the federal government. It's a town's choice to be an active member of the WRC. The WRC is comprised of 27 member towns: the 23 towns of Windham County; Readsboro, Searsburg and Winhall in Bennington County, and Weston in Windsor County. Created in 1965 as a voluntary alliance of towns, the WRC was the first Regional Planning Commission established in the state.

Towns choose their own representatives to serve on the Commission. After town meeting, each Selectboard appoints two representatives to serve on the Commission for the coming year. Halifax is currently represented by Maggie Bartenhagen and Nick Bartenhagen. Commissioners are the foundation of the WRC. Each represents their town's interests before the Commission, brings information from the Commission back to their town, and serves on at least one of a number of committees that address regional and municipal issues and concerns. Active service on these committees is very important because the WRC is organized around a strong committee structure. It's within these committees that most Commission decisions are made. The 10 professional staff of the WRC provides support to the Committees, as well as our member towns.

During the past year we have met with the Selectboards and Planning Commissions of most of our towns, and by June of 2013 we will have met with all towns. These meetings, called municipal consultations, are an opportunity for us to hear from towns about their needs, discuss with them what services we offer, and to provide each town with an assessment of the town's plan (if the town has a plan). These consultations provide us with valuable information, including what trainings, forums and workshops would be most helpful. This year we sponsored a number of regional forums for public officials and the general public, including the Southern Vermont Rivers Conference, a workshop on inter-local agreements, and town roles and responsibilities in the Section 248 energy utility regulation process. In 2013 we're planning forums on town implementation of the National Flood Insurance Program, capital improvement planning, development of grant proposals, and ancient roads, among others.

During the past year we assisted a number of towns with the development of their Town Plans, and revisions to their bylaws. We also continued to provide our towns with mapping and geographic information system (GIS) support. If you see a map in your town's office, more likely than not the WRC produced it. Facilitating communication between FEMA, the state and towns associated with reimbursement for the repair of public infrastructure damaged during Tropical Storm Irene is ongoing, and will be for years as audits follow project closeouts. We've provided assistance with the administration of projects, including the Brattleboro waterfront, Main Street Arts in Saxtons River, and the installation of sidewalks in Putney. We also continued our work on regional issues including transportation, emergency planning, review of Act 250 and Section 248 applications, natural resources, energy, community development, and Brownfields redevelopment. The Windham Regional Plan will expire in 2014, and we've begun the plan update process. To better facilitate and solicit public input, we've created a special website that you can access through the Commission's website at [www.windhamregional.org](http://www.windhamregional.org). We've also created a Facebook page.

2013 will be another exciting and challenging year. In 2012 we made internal changes to meet increased demand for service from both our towns and state agencies without a substantial increase in revenue. We are still adjusting to an 18 percent decrease in the core funding we receive from the state. Collectively, municipal assessments enable us to provide services to all of our towns by contributing to the WRC's funding base. This funding base not only helps us keep the lights on so we'll be here for our towns; it's necessary to provide the non-federal financial match necessary to receive state and federal funding to support our work in areas such as transportation, emergency planning, Brownfield redevelopment, and virtually every other grant we pursue to do work within the Windham Region. We have based our budget on a modest increase in the per resident assessment rate from \$1.68 to \$1.74. The WRC's core budget relies on member town assessments to match and support federal and state funds. The \$1.74 per resident rate will result in a total assessment of \$1,296 from Halifax for the new fiscal year. Halifax may wish to budget additional amounts for town-specific work needed from the WRC. ## Windham Solid Waste Management District Report July 1, 2011 – June 30, 2012

The Windham Solid Waste Management District is comprised of a Board of Supervisors appointed by each of the 19 member towns. The District and its 15 person staff have continued to provide recycling services to its member towns, as well as for several other communities. Residents utilize a network of transfer stations and recycling convenience centers to recycle paper, cardboard, and commingled containers. The District's two roll-off trucks regularly service the recycling locations, and the materials are hauled to the District's materials recycling facility (MRF) on Old Ferry Road, Brattleboro, where the materials are mechanically and manually sorted, baled, and then sold in tractor trailer loads to a network of buyers. Other programs offered by the District include collection/recycling of hazardous waste, electronic waste, and organic waste.

The fiscal year 2012 has been a year of change at the district. Joe Kowalski, operations manager, retired and was replaced by Philip Baker. The Executive Director, George Murray, resigned to take another job, and was replaced by Robert Spencer. Cindy Sterling, Program Coordinator, resigned to pursue other interests, and was replaced by Kristen Benoit, who also serves as office manager.

The total recyclables collected in fiscal year 2012 was 5,890 tons, down from the previous year. However, a strong showing in commodity prices during the summer and early fall lead to the best year ever in sales of the recyclables, with total revenue of \$781,710. This allowed the District to reduce its annual assessment to the member towns by 5 percent. More recently there has been a decline in prices into fiscal year 2013.

Our nickel bottle recovery program, which we have been running for a full year, collected about \$32,647 in fiscal year 2012.

We conducted an inventory and evaluation of all of our 105 roll-off recycling boxes, and have started a program to repair and replace boxes so that they are safe to use and transport on the highway.

Effective July 1, 2011, the Vermont State E-Cycles Program provides FREE drop-off for the collection of computers, monitors, televisions, printers and computer peripherals from Vermont households, school districts, charities, and business with 10 or fewer employees. The WSWMD participates in the state E-Cycles Program. From July 1, 2011 – June 30, 2012, the WSWMD recycled 267,743 pounds of electronic waste. The District is assisting towns in setting up state registered e-waste collection sites.

The District conducted several Household Hazard Waste Collections (HHW) this past year, including several after Tropical Storm Irene to assist residents with the clean up from the storm. The events were held in the towns of Brattleboro, Brookline, Dummerston, Brookline, Halifax, Marlboro, Newfane, Putney, Townshend, Westminster, Whitingham, Wilmington and Winhall, for a total of thirteen of the District's nineteen towns. A total of 525 residents participated in the household hazardous waste collections this past fiscal year (a new record). For detailed information on HHW participation rates, please visit our website.

Carbon Harvest Energy started operation of their greenhouse that will be growing vegetables and fish on a closed portion of the District's landfill. They also started operating a new landfill gas generator that is selling electricity to the grid, and will use the excess heat from the generator to heat the greenhouse in the winter.

The next fiscal year will be a challenging one for our towns with passage of Vermont's mandatory recycling law, Act 148. Starting in July 2014, recycling will be mandatory, and to prepare for this the District is working with our local haulers and town officials to implement expanded services. The new

law also includes requirements for recycling food waste and yard waste, so the District is working to develop a composting facility. The Town of Brattleboro will be conducting a pilot program to collect food waste from its residents, and may implement a town-wide program in the next year.

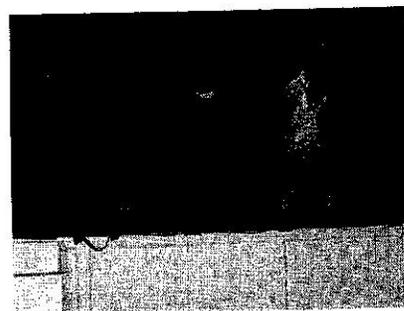

## Report to the Town of Halifax

The mission of the Women's Freedom Center is to work to end physical, sexual and emotional violence against the women and children of Windham County. The Freedom Center works to fulfill its mission by educating the community regarding the root causes of violence against women, challenging the systems that help keep it in place and by providing support and services, including shelter and safe housing, to women and their children who have experienced domestic violence, sexual assault, stalking, and dating violence. Since our beginnings in 1977, we have provided support to the survivors of these crimes, as well as consultation and educational activities to a wide range of community groups to help create a community in which violence is not tolerated.

Emergency support such as shelter, safety planning, financial assistance, and information and referral is available 24 hours a day, 365 days a year. Ongoing individual and group support for women and children; legal, medical, housing and social services advocacy; and cooperative work with other agencies are provided during the week. Due to the rural nature of Windham County and the isolation inherent in many abusive relationships, we are committed to meeting with women wherever we may do so safely. Sometimes this means assisting her to get to us and other times it means us going to her, somewhere safe in her community.

During the fiscal year July 1, 2011 – June 30, 2012, the Women's Freedom Center provided shelter to **56 women and their 43 children**, responded to 1,388 calls, and provided assistance to 392 women and their 309 children through individual and group support, advocacy, referrals, emergency financial aid, housing assistance, transportation, and access to legal representation and childcare. This year the Freedom Center provided emergency support to 3 families from Halifax. In addition, several hundred of the calls received were from callers who did not specify a location meaning some may well have been from your town.

The Women's Freedom Center is a private, non-profit organization relying heavily on community support to provide our free and confidential services. We thank you for your Town's contributions to the Freedom Center, and hope you will look upon it as an investment in creating a future free from violence, something we all deserve.

## Report to the Town of Halifax

Since Youth Services was established in 1972, we have assisted over 1,200 children, youth and adults throughout Windham County every year. We help youth and families thrive. We help youth and young adults living in difficult circumstances learn the life skills that will assist them in living successfully on their own and as engaged and productive community citizens. Program services include:

- Big Brothers Big Sisters one-to-one mentoring
- Transitioning youth in foster care to independent living as young adults
- Assistance to teens leaving home or at-risk for running away with counseling, family mediation, and housing
- Home-based counseling to keep families together, thereby avoiding the placement of children outside their home
- Court Diversion for youth and adults, an alternative to the traditional court system using a restorative justice approach to repair the harm to victims and the community while addressing the underlying issues of the people who violated the law.
- Therapeutic case management services, support and referral
- Career development focused groups and one-on-one mentoring for high school students with behavioral and learning disabilities.
- Drug and alcohol abuse prevention and intervention for youth and adults.

This year, we respectfully request \$200 from the Town of Halifax to help fund our agency's services. We served four residents from Halifax during Fiscal Year 2012. Your continued support is beneficial to the children, youth and families in your town.

The school has continued to meet the goals for annual yearly progress set by the state of Vermont, despite the fact that this bar rises higher each year. The artistic expression, scientific inquiry and sportsmanship seen both in our school day and our after school programs show how diverse the achievements of our students are. The bottom line is that despite a shoestring budget for books, supplies and professional development, this school continues to grow and thrive and does so because of the support of the teachers, families and community members. 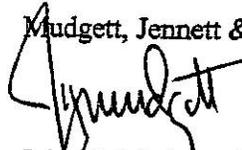
