**I. Introduction**

On January 23, 2015, the District Environmental Commission held a public hearing for the above referenced application the Commission recessed the hearing. As previously noticed, the next hearing will be held on **February 18, 2015**

**II. Information requested**

1. By February 10, 2015, the Applicants shall provide all parties specific information on the type of trucks to be used, including the number of wheels, the loaded and unloaded weight.
2. The Applicants need to address all comments of the Agency of Natural Resources.
3. Information on the quantity of fines that will be generated from drilling and sawing operation on a daily basis and where fines will be stored onsite.
4. Information on whether the fines have a different settling rate than materials usually managed by the stormwater mechanisms to be employed. Are, for example, the settling rates different for this type of material which could affect the successful function of the stormwater systems? The Commission would like to receive information on this issue from both the Applicants and the ANR Stormwater program.
5. Information on how drilling will be done to prevent contact with groundwater? Also, the Commission would like information from the Agency of Natural Resources as to the potential for groundwater impacts from the project and how to best avoid them. The Commission received evidence that an abutter has a (bedrock?) well at 75 feet in depth. The Applicants apparently have not performed any test wells and do not know the depth to groundwater in the area where material would be removed.
6. Assessment of Impact on logging road and what stabilization may be required.

An appeal from this order may be filed with the Environmental Court in accordance with 10 V.S.A. Chapter 220 and the Rules for Environmental Court Proceedings.
